APPLICATION AND REVIEW PROCEDURES

Application and review procedures that will be used by the AC (Architectural Committee) are detailed below.

Applications. All applications for proposed improvements must be submitted in writing using the
application forms authorized by the AC. Applications must be complete in order to commence
the review process. Incomplete applications will be returned to the applicant with a statement of
the deficiencies that must be remedied in order to be considered for review.

- 2. <u>Supporting Documentation</u>. The application must include a complete and accurate description of the proposed improvement(s). To permit evaluation by the AC, supporting exhibits will frequently be required. Examples include: a site plan showing the location and dimensions of the proposed improvement; architectural drawings or plans, as applicable; landscape plan; material and/or color samples, etc. The design guidelines and application forms provide guidance with respect to the supporting documentation required for various types of improvements.
- 3. <u>Time Frame for Completion of the Review</u>. The AC is required to approve or disapprove any proposed improvement within thirty (30) days after the receipt of a properly completed application. However, the thirty (30) day review period will only commence upon the receipt of a complete application form, including all required exhibits. It is therefore advisable for homeowners contemplating substantial improvements to first ensure that they are aware of all required supporting documentation prior to submitting a design review application.
- 4. <u>Notice of Approval/Disapproval</u>. Homeowners who have submitted design review applications will be given written notice of the decision of the AC.
- 5. Appeals Procedure. Homeowners who have submitted design review applications may appeal decisions of the AC to the Board of Directors (BOD). A homeowner may appeal a decision of the AC by submitting a written request to the BOD within fourteen (14) days after the date of action by the AC. This request should include any new or additional information that might clarify the requested change or demonstrate its acceptability. The Board may, at its discretion, conduct an informal hearing related to the appeal. The Board will respond in writing to an appeal within forty-five (45) days from the date of receipt of an appeal.

A picture representation drawn on a copy of the recorded plat, drawn to scale, showing the location and dimensions of the proposed improvement, including orientation with respect to the property lines and owners home. b) Architectural Drawings and Landscaping Plans. Detailed architectural drawings or plans must be provided for decks (top and side view with dimensions) and structural additions to the home and major landscape improvements which would change the topography of the lot or landscape plan originally provided by the builder. c) Paint or stain colors. A sample and model number of the color(s) to be used must be provided, both for repainting and re-staining existing improvements and for structural additions, together with a list of existing paint colors on the house or appurtenant structures which will remain unchanged. d) Finish Materials. A description or sample of all finish materials to be used for the exterior surface of the proposed improvements must be provided. e) Other exhibits. Other exhibits may be required in order to permit adequate evaluation of the proposed change. Homeowners are advised to seek guidance from the AC prior to submission of an application. - 1. Nothing contained herein shall be construed to represent those alterations to lots or buildings in accordance with these plans shall not violate any provisions of local building and zoning codes to which the above property is subject. Further, nothing contained herein shall be construed as a waiver or modification of any said restrictions.
- 2. Where required, building permits shall be obtained prior to the start of any construction. Nothing contained herein shall be construed as a waiver of said requirement.
- 3. Owner understands and agrees that no work on this request will commence until written approval has been obtained from the Architectural Committee (AC).
- 4. Owner further understands and agrees that any exterior alteration undertaken before written approval is obtained is not permitted and that the Owner may be required to restore the property to its former condition at Owner's expense is such alterations are made and subsequently disapproved in whole or part. Further, Owner understands that any legal expense associated therewith may be the responsibility of the Owner.
- 5. Owner agrees to give the AC and/or BOD, express permission to enter on the Owner's property at a reasonable time to inspect the proposed project, the project in progress and the complete project.
- 6. Owner understands that any approval is contingent upon the completion of alterations in a workmanlike manner and in accordance with the approved plan and specifications for said alterations.
- 7. Owner acknowledges that he is familiar with the design review requirements and procedures for the Nettle Creek Country Club Estates Homeowners Association.
- 8. Owner understands that the authority to perform an alteration granted by this application will automatically expire if work is not completed within twelve (12) months from AC approval.
- 9. The lot owner or representative confirm the items listed in Attachment 1 and/or 2 are in compliance with Nettle Creek Country Club Estates Covenants.
- 10. The lot owner or representative has been informed that they may be held responsible for damage to the street, streetlights, sewers or storm drainage system that occur during the construction of this structure.
- 11. The lot owner or representative has been informed that they may be held responsible for damage to the golf course property. The cart path is not to be used as a roadway.

Application for Landscape or Pool

Original landscape plans should be submitted within 30 days of occupancy. Landscaping must be completed within 90 days of occupancy, unless the home is occupied during the winter months. In that case, landscaping must be completed by the next June 15th.

A scale drawing or survey of your lot should include the following:

- Location of all applicable items below:
 - House
 - Driveway
 - Garage
 - Sidewalk

- Porches
- Deck
- In-ground Swimming Pool
- Storm drains, inlets or manholes
- o Two (2) trees within the parkway adjacent to the lot being a minimum of 2" caliper diameter of these types - Soft Maple, Hackberry, American Linden or Honey Locust
- o Two (2) trees within the rear twenty-five (25) feet of the rear lot line being a min. 2" caliper diameter of these types - Soft Maple, Hackberry, American Linden or Honey Locust
- Location of all proposed plant beds, natural areas and plantings
- Yards will be seeded or sodded with grass
- No fences shall be erected on any lot, except around swimming pools as required by local or state law. Decorative hedges not more than six (6) feet in height are permitted, except within the Open Landscape Area, being the rear thirty (30) feet of each lot.
- o No antennas used for CB's or ham radio operations will be installed on any lot within this subdivision.
- No TV satellite dish or antenna shall be installed or located in the Subdivision without written approval as to size and location by the Architectural Committee
- o Owner has 90 days after home is occupied, or because of the season of the year, no later than June 15th following occupancy to install landscaping.
- In-Ground Swimming Pools:
 - Drawings to include swimming pool dimensions
 - Swimming Pool apron size and material shall be indicated on drawing
 - o Fences shall not extend more than six (6) feet around the swimming pool apron.
 - o No fences shall be erected within the Open Landscape Area, being the rear thirty (30) feet of each lot.
 - Swimming pool fence type shall be submitted for approval by the AC.
